Professor WANG Na is Associate Professor at the Shanghai University of Political Science and Law. She is also Shanghai's "ChenGuang Scholar", Member of the Tenth Sino-French "European Law Training Project" (Visiting Scholar at University of Paris - I Panthéon-Sorbonne in France supported by China Scholarship Council), Deputy Chief Procurator of the People's Procuratorate of Minhang District of Shanghai Municipality (2012-2013), Member of the Council of Chinese Criminal Law Society, Member of the Council of Chinese Society of Criminology, Member of the Council of Chinese Society of Comparative Law, Member of International Association of Penal Law and Member of International Society for Criminology.

Professor WANG Na's main research areas include Penal Law, Criminology, Criminal Justice System (Procuratorial System) and Comparative Law. She has authored, co-authored, edited and co-edited ten books: *Criminal Pardon System* (Author, 2008), *Research on Reconstruction of Modern Amnesty System* (Co-Author, 2011), *Oriental Comparative Jurisprudence* (Volume 1) (Editor, 2014), *Research on Drug Abstinence* (Editor, 2014), *Oriental Comparative Jurisprudence* (Volume 2) (Co-Editor, 2016), *Penal Law for Practical Training* (Editor, 2016), *Research on Juvenile Delinquency and Juvenile Justice* (Co-Editor, 2017), *Kyrgyzstan's Path Toward the Rule of Law* (Co-Author, 2017), *Comparative Study on Anti-terrorism Legal Mechanism of Shanghai Cooperation Organization* (Co-Author, 2017), *Oriental Youth Forum* (Volume 1) (Editor, 2017). Professor WANG Na has also contributed articles in magazines and newspapers published in China. She presides over "Oriental Forum on the Procuratorial System" and "Oriental Youth Forum". She is responsible for several research projects as a host in China and participates in several international cooperation research projects.

Professor WANG Na obtained her Bachelor of Laws (LL.B.) degree from Law School of the South-Center University for Nationalities in 2000, China. She obtained two masters, one from School of Law of Wuhan University in 2003, China (Research Field: Criminology) and the other from Université Paris 1 Panthéon-Sorbonne in 2011, France (Research Field: European Union Law). She has obtained her Ph.D. degree from School of Law of Wuhan University in 2007, China (Research Field: Comparative Criminal Law).
