

ELIGIBILITY CRITERIA:

Successful completion of Class XII examination or equivalent (CBSE, ISC, IB, Cambridge, State Boards, and other government recognized school leaving examination). Student securing more than SAT (1100 Marks) / ACT (27 Points) / UGAT OR CUET 60 Percentile & Above) are exempted from the JSAT (Jindal Scholastic Aptitude Test) entrance exam.

SELECTION PROCESS:

Applicants are selected through a holistic admission process conducted over three rounds based on X and XII grades, Entrance Exam Scores (Jindal Scholastic Aptitude Test JSAT, SAT, ACT, UGAT, CUET) and Personal Interview.

SCHOLARSHIPS

- JSBF offers scholarships on Merit cum Means Basis.
- Minimum 80% marks (Overall in Class 12th).
- Parents combined Gross Total Income should be less than Rs. 50 lakhs per annum for each assessment year. Last 2 Years are taken into consideration.
