Siddharth has extensive experience in private equity and venture capital transactions as well as expertise in cross-border and domestic M&A, corporate finance and general commercial law. He obtained a B.A., LL.B. (Hons.) from the National Law School of India University, Bangalore, (1997) and an LL.M. in International Economic Law from the University of Warwick Law School, UK (1998), where he was a Foreign & Commonwealth Office Chevening Scholar and a J. N. Tata Scholar. Siddharth is admitted to practice law in India and in England & Wales (currently not practising) and has previously been a visiting faculty member at the Department of Management Studies of the Indian Institute of Science, Bangalore, the oldest management studies faculty in India where he taught a course on Business Law in 2006 and 2007. Siddharth was also one of the Consulting Editors of "Business Law Reports", a leading report designed to cater to the business and legal fraternity and published by Manupatra.
