Dr. Akhil Prasad is Country Counsel India and Company Secretary with Boeing International Corporation. In past, he has held offices as Head of Legal and Company Secretary with Fidelity Worldwide Investment (2007 to 2013); Director India Legal Affairs & Company Secretary of The Walt Disney Company India (2005 to 2007); as Senior Attorney & Company Secretary of General Motors India (2003 to 2005); and as Assistant General Manager Legal with Electrolux Kelvinator (2000 to 2002). Prior to these assignments, he has also worked with the legal teams in Modicorp Group (including Modi Xerox and Graphtech India from 1995 to 2000).

Akhil has worked across various industries in the area of legal, risk and compliance, taxation, regulatory and corporate affairs.

Akhil is a visiting faculty with the National Law University - Delhi and Jodhpur, Delhi School of Economics, the Indian School of Business; the Department of Management Studies of the Indian Institute of Technology, Delhi (IIT-Delhi); the Management Development Institute; OP Jindal Global University; and the Indian Institute of Management Kashipur (IIM-K).
